



## **'Dogs wrap up action at 2018 U23 World Team Trials**

**AKRON, Ohio** - The 11 Bulldog Wrestling student-athletes representing the Valley Regional Training Center at the 2018 U23 World Team Trials concluded action on Sunday morning at the Louis and Freda Stile Athletic Field House on the campus of the University of Akron.

Freshman [Jackson Hemauer](#) at 86 kg. won a team-high five matches coming within one win shy of placing in the top eight in his weight class. All 11 wrestlers won at least one match while four-time California High School state champion, Justin Mejia, also wrestled representing the Valley RTC going 1-2.

"It was a great learning experience for our guys to compete in this tournament, one of the toughest in the country, and we will get better from this," said assistant coach [Israel Silva](#).

Participating athletes are students who are currently officially registered as proceeding towards a degree or diploma at a university or similar institute whose status is recognized by the appropriate national academic authority of their country. All competitors must be U.S. citizens - born 1995-1999 (19-23 years old) or 2000 with medical certificate.
