Duke Drops Home-Opening Dual to Central Michigan

DURHAM – Duke wrestling fell 35-4 to Central Michigan on Thursday night in its home-opening dual in Cameron Indoor Stadium.

HOW IT HAPPENED

- Senior **Jonah Niesenbaum** earned the Blue Devils' lone points after securing a 11-3 major decision win over Bryan Caves. The Allentown, Pa., native scored takedowns at the end of all three periods to help his cause.
- Redshirt junior **Patrick Rowland** and redshirt senior **Brayden Ray** each put up tough battles against their Chippewas opponents but fell just short. Rowland dropped a 6-5 decision while Ray fell 3-1 in sudden victory.
- Redshirt senior **Gabe Dinette** made his season debut for the Blue Devils but fell in a 10-2 major decision to Tracy Hubbard.
