No. 20 Purdue Wrestling Sweeps Boilermaker Duals

WEST LAFAYETTE, Ind. - The No. 20 Purdue wrestling team improved to 6-0 Sunday, topping a trio of opponents at the 2021 Boilermaker Duals at Holloway Gymnasium. Purdue took home 24 of their 30 matches on the day, defeating Brown (42-0), Duke (28-15) and Northern Illinois (28-10).

Five Boilermakers turned in perfect 3-0 days as seniors Devin Schroder and Parker Filius, juniors Kendall Coleman and Thomas Penola, and freshman Matt Ramos combined for perfect afternoons. Schroder was three-for-three with bonus points, posting a pair of technical falls and a major decision, as was Coleman who scored 24 takedowns in a technical fall and two majors. Not to be outdone, Penola posted two of his three wins with bonus points, posting a technical fall and a major decision with 19 takedowns on the day. Filius had a trio of decisions to improve to 6-0 this season at 141 pounds, as did Ramos, who earned two decisions and accepted a forfeit at 133 pounds.

Seniors Max Lyon and Michael Woulfe, and sophomores Emil Soehnlén and Gerrit Nijenhuis all had a pair of wins on the day. Woulfe posted his team-best fourth fall of the season, while Lyon and Soehnlén each scored their first of 2021-22. Sophomore Trey Kruse put up his second dual victory of the season, earning a 10-2 major decision in the Boilermakers' sweep of Brown.

Purdue's 42-0 shutout win over Brown was the Boilermakers' first blanking of a Division I opponent since a 39-0 win over Southern Illinois Edwardsville in 2014, and their first 40-point showing against a DI foe since hanging 41 on Wisconsin in 2012. The Boilermakers improved to 5-1 all-time vs. Brown, 3-1 all-time against Duke and won their ninth straight over Northern Illinois, pushing to 23-8-1 in series history.

The Boilermakers return to action Dec. 3, heading to Las Vegas for the Cliff Keen Las Vegas Invitational, hosted at the Las Vegas Convention Center.
